#### \* **SPECIAL NOTE FOR CUSTOMS AND HEALTH DOCUMENTATION**

**England & Wales:** For both oysters and marine copepods, you will need to register with Cefas as an importer. A notification form is required for each shipment, which we can fill out for you and simply forward onto you to sign.

**Other destinations:** Customers must advise us of any import conditions and required paperwork. For most European countries, we believe there is no requirement for animal health documentation for samples sent for laboratory testing. However, to help avoid possible delays, customers are requested to provide an 'End Use Statement' confirming that all material will be destroyed and not released to the environment.

The value stated in the despatch note is the nominal intrinsic value of the samples. The invoiced amount is for providing the specialist service of culturing and conditioning.
